

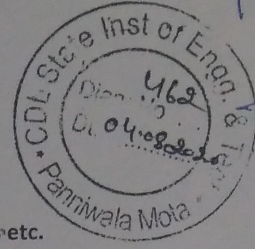

Sir/Madam

As per notification issued by the Academic Branch vide Endst. No. Acad AC-II/M-5/2020/1670-1735 dated 19.05.2020, the last date for submit of Dissertation/Project Work/ Internship Reports etc. of various courses being run in your college will be 31st August, 2020 without late fee. Further, regarding M.Tech programmes, the notification may read as under:-

"The students may be allowed by the respective Chairperson to complete their Dissertation work on rotation basis, without violating the norms of 'social distancing' and guidelines of COVID-19 pandemic. The date of submission of Dissertation/Project Report may be extended upto 31.08.2020 without late fee, in this juncture, as a special case. Thereafter, the late fees will be applicable as per existing rules of the University.

The viva-voce examinations of Project Reports/Dissertation/Thesis etc. submitted by the students will be conducted through Online mode using video conferencing tools of other reliable and mutually convenient technology and due record of the same be maintained."

Therefore, in view of the notification I have been directed to inform you that the students of various courses may be directed to submit their Dissertation/Project Work etc. with fee of Rs. 4000/- upto 31st August, 2020 and with fee of Rs.5000/- (Rs.4000/- submission fee + Rs. 1000/- late fee) upto 30th September, 2020 for main exam. May/June, 2020. If a candidate fails to submit his/her dissertations etc. upto 30th September, 2020, he/she will be treated as "absent". However, the re-appear students can submit their Dissertation/Project Work etc. with submission fee of Rs.4000/- upto 31st August, 2020 for the session May/June, 2020 and late fee as per rule.
