Sir/Madam

The re-appear theory for UTD Engineering courses and Affiliated Engineering Colleges (except MBA & MCA) for the Session May/June 2020 students enrolled with your institution has been commence 12.10.2020 onwards. Keeping in view the COVID-19 pandemic situation and considering the facts that some students are from very far places, the online examination option is given to the students in addition to the offline mode for this session (May/June 2020) only

You are required to provide data of the students who wants to appear through online mode in the prescribed Excel format (enclosed) by today upto 5.00 pm positively. Thereafter, no request will be entertained and the concerned colleges will be responsible for consequences, if any.

For online mode of examination you are requested to inform the students regarding the following guidelines towards conduct of online examinations:

1. Monitoring/proctoring of the students adopting online exam mode be taken care of by the University itself.
2. The question paper for offline or online, will be the same and will be of same pattern as per past practice and will be conducted at same time.
3. The students are required to use maximum 30 A-4 size pages for attempting the question papers.
4. The students appearing online have to give following undertaking to the concerned colleges:
  - i) I will adhere with schedule of online examinations as notified and will not claim for offline examinations thereafter
  - ii) I am agreed with type of questions in question paper as mentioned in notification of online examination and allow university for monitoring and video recording during examinations.
  - iii) I will arrange hardware (desktop/laptop with good camera) and internet on its own and will be responsible for functioning of hardware and internet.
  - iv) I will not claim for malfunctioning of hardware/failure of internet or uploaded blurred (non readable) image.
  - v) I will not leave my position in front of camera during tenure of examinations. Any doubtful activity of me may be considered as unfair mean case (UMC).
