Lai State Institute of Engineering & Technology, Panniwala Motta, Sirsa, for B.Tech. (Civil, CSE, EE, ECE, ME) with an intake of 60 seats for each programme and B.Tech. (FT) with an intake of 30 seats for the Academic Session 2018-19 has been granted by the Vice-Chancellor subject to the fulfilment/removal of the following conditions/deficiencies within six months:

 Vide letter No. CDLSIET/2017/349 dated 01.06.2017, the Institute has requested the Govt. to initiate the process of repruitment of faculty.

 The Institute has sent office notes to DGTE for purchase of Lab Equipment for various departments in the months o April and May 2018.

Situation has not changed on both the points (1 and 2 above) raised in the letter
of extension of provisional affiliatio (2017-18.

4. The labs of the EE, ECE, ME and Civil Engineering Departments were found lacking in following respects:

a. The equipment in Control Lab are yet to be procured for conducting all requisite experiments; as of now, only three experiments kits are available in Control Lab.

 A computer lab needs to be established in EE Department wherein students can effectively do computer related experiments.

c. Requisite numbers of experiments need to be performed in each lab.

d. Licensed software needs to be procured for labs of ECE & ME Department.

e. Lab such as Microwave DSD, Radar etc. need to be established by procuring the apparatus expediently.

f. Some labs need to be established in Mechanical Engineering Department such as Material Science lab, Steam and Power Generation, Fluid Machines, I.C. Engines and Gas Turbines, Measurement and Instrumentation & Automob le Lab.

g. Some of the existing labs need to be strengthened in terms of equipi such as Fluid Mechanics lab, Heat Transfer lab & Product Technology lab.

h. Some labs need to be established in Civil Engineering Department s as Structure Analysis lab, Transportation Engineering

Environmental Engineering.

 Some of the existing labs need to be strengthened in terms of equipm such as soil Mechanics & Geo Technology lab.

You are, therefore requested to take necessary steps to fulfill/remove conditions/deficiencies as pointed out and submit the compliance report within months.
